This contract for advertising on the Greater Cleveland Chamber of Commerce, hereinafter Chamber, website is made between the Chamber and _____, hereinafter Advertiser. This contract spells out terms and conditions of banner advertising on the website Greatherclevelandchamber.com, hereinafter website.

The Chamber is responsible for the maintenance of the website and for making sure that the website is up and in working order at all times. The Chamber has the final say on the content of any advertising on the website and shall not be compelled under this contract to display any advertising that the Chamber deems inappropriate.

The Chamber does not promise or guarantee any results from the advertising and has the right to bring an action in the Courts of the State of North Carolina to collect any all funds due to it under the terms of this contract.

All parties agree that they are entering into this contract on their on free will and fully understanding what they are doing and all the terms are stated herein. There are no oral agreements outside of this contract and all amendments to the contract must be in writing. The Chamber is allowed to request a reasonable attorney fee and the cost of the action if it has to bring an action for collection of fees under this contract and the Advertiser is found to have breached this contract.

The Advertiser has read and fully understands this contract and the Advertisers representative signing below has the legal authority as an agent to bind the Advertiser. The Advertiser and its agent also acknowledge receipt of a copy of the contract.
