

**Food Vendor Application / Contract**  
**April 24, 2010 - Strawberry Festival**

**Rules & Regulations:**

1. The Strawberry Festival is sponsored by the Greater Cleveland Chamber of Commerce.
  2. Only those individuals who fill out a completed application, certificate of liability insurance form, provide a current tax I. D. Number will be allowed to sell.
  3. No Generators are allowed: vendors are required to bring their own drop cords.
  4. Power supplied by GCCC with (1) 50 amp/220V & (4) 20 amp/110V.
  5. All Vendors must be set –up by 6:00am and vehicles out of festivals site by 6am.
  6. All food vendors are required to abide by the rule and regulations developed by the Heath Department and Fire Marshal.
  7. Vendors are required to set up their own booth. No tables, chairs, etc. will be provided. Vendors shall arrange booths so that it will not interfere or obstruct view of other booths.
  8. All vendors are responsible for reporting their own taxes.
  9. The GCCC is not liable for damages, injury, or loss of any person or goods from any cause whatsoever. The GCCC can not be held responsible for any claims for damage, injury or loss arising out of or in connection with the use of space or grounds in this festival.
  10. No refund, all booths have to be paid in full.
  11. Limited space is available on first come, first served bases.
  12. The GCCC reserves the right to approve all food. The decision of the GCCC will be final.
